A contractor's chart of accounts is the heart of the accounting system. Of particular importance is the cost of sales section (beginning in the 41000 series and ending in 43000). This is the area that distinguishes the contractor from most other industries and causes the most confusion for the bookkeeper.

The legal requirements relating to the annual accounts are included in Title 9 Book 2 (hereinafter: Title 9) of the Netherlands Civil Code (NCC). Title 9 is applicable to the annual accounts of certain types of legal entity, such as the public limited liability company (N.V.) and the private limited liability company (B.V.).

Accounts Receivable Trade accounts receivable are stated net of an allowance for doubtful accounts of \$7,500 at December 31, 20YY and 20XX. Virtuoso estimates the allowance based on its historical experience of the relationship between actual bad debts and net credit sales
